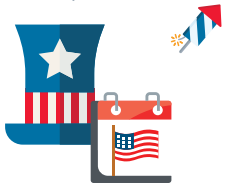

Get your receipts here!

Promotion brought to you by 

In order to benefit both Justice Chamber of Commerce businesses and our residents, the Chamber presents Shop Local & Win. We'll start the promotion in early March.

The simple version is that customers who shop at three different Chamber businesses in a month can turn in their receipts to the Chamber for a raffle ticket. Two raffle winners will be drawn each month and each winner will receive \$50 in Chamber Bucks (in \$10 denominations, so they don't have to spend it all at once). The Chamber Bucks can be spent like cash at any participating Chamber business. The business will then turn in the Chamber Bucks to the Justice Chamber of Commerce and we will give them \$10 cash for each Chamber Buck they've collected from customers. v

Here are the details:

- Only businesses that have an active Justice Chamber of Commerce membership will be able to participate. Participation is voluntary and a business may decide to opt in or out at any time.
- Each business that participates will receive:

- A promotional sign to post on their door or window. (After the local elections are over, we are planning to purchase lawn signs, too.)
- Instructions for the business employees
- Promotional rules and info page to hand out to customers
- For non-retail businesses we will provide a printed "receipt" for reproducible paper, so they can't be copied.
- The businesses will each need to decide what qualifies as a "purchase" for them. Here are some ideas....
- The Justice Public Library we'll hand them out to patrons that come in to use the computer, check-out library material, renew their cards, etc.
- The village of Justice might give out receipts to people who come in to pay their sewer bills, get vehicle stickers, etc.
- An insurance, trucking, or auto repair company might want to give them out to customers who come in for quotes.

Customer instructions:

- Collect 3 receipts from 3 different participating JCC businesses. Either a retail receipt (\$10 or more) or a non-retail receipt as described above will qualify.
- For each 3 receipts turned in the customer will receive a raffle entry form. Customers may enter the raffle more than once. The receipts can be turned in at the Justice Public Library.
- If the customer needs to keep their receipt (for a warranty, business reimbursement, etc.) then the receipt will be marked with "JCC Raffle," so it can't be used again.
- Customers will fill out their name and phone number on each raffle ticket, then the ticket will be entered in the drawing for that month.
- If a customer wins the raffle, he/she will receive \$50 in Chamber Bucks (5 @ \$10 each). The Chamber Bucks can be spent like cash at any participating business. No change will be given, so if a winner only buys \$5 worth of merchandise and uses a Chamber Buck to pay for it, he/she will lose the other \$5.

Raffle information:

- Drawings will be held once per month.
- Each month 2 winners will be drawn. Winners will be notified by phone.
- Once notified, winners will have 30 days to pick up their prize. If the prize is not claimed within 30 days, a new winner will be drawn.
- Each winner will receive 5 Chamber Bucks, worth \$10 each, for a total prize amount equaling \$50
- Non-winning raffle tickets will be shredded each month after winners have picked up their prizes. So, each month the raffle tickets entered will be only those turned after the last drawing.
- Chamber businesses that collect Chamber Bucks from customers will notify the Chamber and we'll reimburse them \$10 cash for each Chamber Buck they've collected.

Sponsor Information

- Businesses or individuals that donate \$250 or more will be listed as sponsors on our promotional signs and our website.
- All donations will be used to fund the raffle prizes.

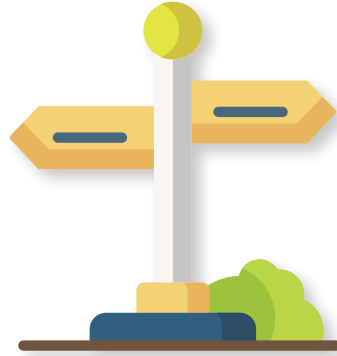
CONSTRUCTION UPDATES

Archer Avenue Interchange Project



To accommodate the rebuilding and widening of the Central Tri-State Tollway (I-294), the Illinois Tollway will reconstruct and improve several ramps and bridges providing access to Archer Avenue, including construction of the new ramp connecting westbound Archer Avenue to Northbound I-294. Work to be completed in 2021 will include the start of work to reconstruct the ramp connecting eastbound Archer Avenue to southbound I-204, as well as the construction of a new ramp that will connect westbound Archer Avenue to northbound I-204. Work is also scheduled to be completed on

the reconstruction of the Archer Avenue Bridges over I-204, which include drainage, lighting improvements and landscaping. Construction began in spring of 2020 and is scheduled to be completed by the end of 2022.



Roberts Road/87th Street I-294 Bridge Reconstruction Project

The IL Tollway has started reconstructing the I-294 bridge located at 87th Street and Roberts Road. In 2021 the Southbound side will be constructed and the Northbound side construction will begin in 2022. Once the IL Tollway complete the bridge, the Cook County Department of Transportation and Highways will reconstruct the complete intersection at 87th Street and Roberts Road. Cook County anticipates beginning the reconstruction of the intersection in 2023.

88th/Cork Avenue Interchange Project

The long-envisioned 88th/Cork Avenue interchange on the Central Tri-State Tollway (I-294) in Justice will unlock new access and relieve congestion in the area. The goals of the 88th/Cork Avenue Interchange Project are to create access to and from I-294, improve flow of traffic, reduce congestion and foster economic development and job creation in the southwest region. The project includes construction of a new northbound exit ramp from I-294 to 88th/Cork Avenue and a southbound entrance ramp from 88th/Cork Avenue at 79th Street and Archer Road. The new interchange is designed to be compatible with a new northbound I-294 entrance ramp from southbound Archer Avenue scheduled to be constructed by the Illinois Tollway as part of the Central Tri-State Tollway (I-294) Project. The new ramps will also allow for consolidation of local southbound entrance ramps from Archer Avenue on the new 88th/Cork entrance ramp location. In partnership with the Illinois Tollway and Illinois Department of Transportation, the



Village of Justice is leading the project's design and Cook County will be constructing the project improvements. The Village of Justice and Cook County have partnered together and collaborated with the Illinois Tollway to receive a grant from Illinois Competitive Freight Program for \$1.8 million to be used for right-of-way acquisition for construction of the new interchange. The project is compatible with Cook County's long-range investment in Cook Initiative to encourage business development and growth by improving freight and traffic connections across the county. The new interchange will be part of the enterprise zone created by the Village of Justice and

will encourage new construction and support job creation in the village, as well as opening up an entryway to Justice and other surrounding communities to relieve traffic congestion and provide easier access to local/regional destinations.

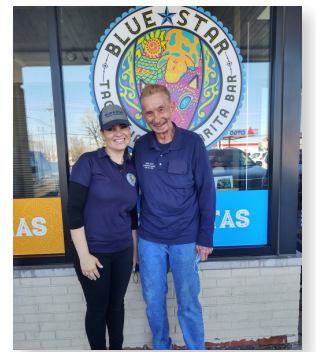


Blue Star Taqueria & Margarita
